Item No. 2: Any other item(s) with the permission of the Chairperson.

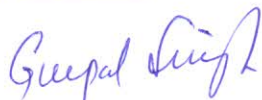

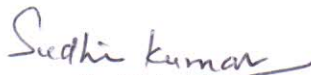
